Coverage Limitations:

- Prior authorization is required for some rehabilitative and therapeutic services.
- Cardiac rehabilitation is limited to up to 12 weeks following hospital discharge, and up to 26 weeks for risk reduction, illness adjustment and therapeutic services. An extension beyond 26 weeks requires additional authorization.

Exclusions:

Please refer to physical, occupational and speech language therapy CMP for a list of exclusions. Group occupational and speech language therapy is not covered.

Extended Family Planning (EFP) members are not eligible for rehabilitation therapy services, EFP is not a comprehensive benefit package.

Vocational rehab services and therapeutic services that are rendered through the schools are out of plan services.
